## **Melele aurok (melele ear kōkkāāl ilo Okwoj 5, 2020)**

- "waiting week" (Wiik in kōttar eo) emōj kōmelim ñan claim ko rar bael ilo ak ālikin Maaj 8, 2020 einwōt mōttan idin kakien ko kin COVID-19.

Ilo ien am kadedelok uwaak ko am, kein jermal eo enaj kenono im kowalok enaan eo, "**Emōj kōmelim kajitōk eo am (Your claim has been accepted).**"

### Kolla ko wonnam kwōj aikuj kōjella kaki ekoba:

1. Bwe in joñan kolla jen bijnej eo am make.
2. Kolla ko jet im rejab iwōj ilo jaan, einwōt reen ak jikin kiki im mōñā.

3. Jibañ jen bonus ko rej jen jermal ko an wiik eo.
4. Tip ko ilo jabdewõt wāween.
5. Kolla in kakkije im jab jermal, raan in kakkije ko, ak kakkije kin nañinmij.
6. Kolla jen Military Reserve im National Guard ñe kwar jermal lablok jen jilu raan kaju.
7. Kolla jen am kar jermal ilo jikin ekajet ñan roñjak im lelok jemlok in keij.
8. Kolla ko wonaam jen katak im jermal an state (ejab koba jaan ko an Taitol IV).
9. Kolla jen jikin jermal, einwõt kolla ko jen törre ko maanlok (ekoba kolla ko jen törre ko maanlok kin an kar jako awa ak claim in jibañ an rijermal) ñan wiik ko kwar claim.

## Kajitōk ko kim ej kajitōk kin claim in PUA an kajojo wiik

Rej aikuj iomwin Kakien eo ej kaju lelok jibañ ñan armij, baamle, im bijnej ko jen jorren ko rar walok jen coronavirus (Coronavirus Aid, Relief and Economic Security, CARES) im claim ko remaron naj bwinne jejetin an kar jermal jen Ra eo ej Bōk Eddon Jikin Jermal ko ilo Amedka (U.S. Department of Labor). Elañe ejako am maron tōbrak ñan jibañ eo an ejellok jermal jen jorren eo elab emōj an jelōte aoleben lal in (Pandemic Unemployment Assistance, PUA), kwōmaron bar kateruru ñan jibañ eo ekkā an ejellok jermal.
